Current Fee Structure:

Therapy:

- Initial Assessment with report at Clinic £200
- Initial Assessment within 10-mile radius £220
(home visit, school/ nursery visit)
- Complex Initial Assessments £250-£500

Assessments will include if appropriate: preparation of suitable assessments, case history taking, informal, formal assessments of the client's speech and language skills, of up to 1 hour session time, liaison with family members, carers and key professionals, analysis of assessments, a short report (200 words maximum) and administration.

- 1:1 Therapy sessions £85 at clinic (45-60 minutes)
- School visit therapy session £160

Review Reports

- Summary review report £100 (500 words max)
- Detailed review report £125-150 (500-1500 words max)

Home Programmes

- Personalised care plans £60-£90

Arrangements for payment:

- Payment should be made within 7 days of the session and the client will be invoiced with payment details following the session.
- Cancellation of the session should be made with at least 24 hours notice, where possible and reasonable, otherwise a fee of the session may be charged between £30 and the full session rate depending on notification.
